SHOW CAUSE NOTICE

WHEREAS, J L Neheru College of Educational & Social Welfare Trust, Plot No- 4152, Street/Road- Badsahi Road, PO- Purba Nuwapara, Tehsil/Taluka- Nutunhat, Town/City- Burdwan, Dist- Bardhaman, West Bengal- 713147 had applied through online dated 28.12.2012 for grant of recognition / permission for conduct of D.El.Ed. of two years duration under the institution viz. J L Neheru College of Education for Women, Plot No- 4152, Vill- Nowapara, PO- Purba Nuwapara, Tehsil/Taluka- Nutunhat, Town/City- Burdwan, Dist- Bardhaman, West Bengal- 713147 (ERCAPP1620) Under Section 14/15 of the NCTE Act 1993 and hard copy of the application was received on 01.01.2014 by the ERC office.

2. AND WHEREAS, the ERC in its 244<sup>th</sup> meeting held on 08<sup>th</sup> – 09<sup>th</sup> October, 2017 after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act., the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqrs. from time to time, discussed the matter in detail and observed as under:

- (i) The institution has not submitted the transferred land deed in the name of J.L. Neheru College of Education.

**In view the above, the committee decided as under:**

A Show Cause Notice be issued to the institution to submit reply within 21 days.


3. And whereas the Committee is of the opinion that the institution prima facie, does not fulfill the requirements, the norms and standards laid down by the NCTE in accordance with the provisions of the NCTE Act, 1993, as detailed above.

4. Now therefore, as per the Section 15(3)(b) of NCTE Act, 1993, before the Regional Committee passes the final order on your application, you are hereby given an opportunity for making such written representation within **21 days** of issue of this notice along with the supporting documents.




