ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Pramatha Memorial Trust, Plot No.- 753, Street/Road- Siur Road, Vill.- Siur, Town/City- Siur, P.O.- Mohubona, Tehsil/Taluka- Sadaipur, Town/City- Suri, Dist.- Birbhum, West Bengal- 731102 has applied for grant of recognition to **Sidhidata Sriniketon Siksha Mandir B.Ed. College, Plot No.- 753, Vill.- Siur, P.O.- Mohubona, Tehsil/Taluka- Sadaipur, Town/City- Suri, Dist.- Birbhum, West Bengal- 731102 (Code No. ERCAPP3099)** for B.Ed. programme online on **30.05.2015** for two year duration and hard copy received by Eastern Regional Committee of NCTE on **13.06.2015**.

2. **AND WHEREAS**, the ERC in its 205th meeting held on 20th - 21st February, 2016 considered the matter and as decided. Refusal Order u/s 14(3)(b) was issued on 03.03.2016 to the institution on the following grounds:-

- a. Show cause notice was issued on 11.02.2016 on the following ground:
 - (i) The land document submitted by the institution is in the name of Sri Narayan Mandal S/o Pradeep Kumar i.e. in the name of individual which is not acceptable as per NCTE Regulation 2014.
- b. Now, the institution submitted "Porcha" vide letter dated 10.02.2016 which is not considerable.

3. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 03.03.2016. The Appellate Authority vide its Order No.89-283/2016 Appeal/9th Meeting-2016/35593 dated 04.08.2016 remanded back the case to ERC for processing of the case further after seeking relinquishment deed from the applicant favour of the Trust. Applicant should get a relinquishment deed registered in the name of trust and submit a copy thereof to the ERC within 30 days of the issue of appeal orders.

4. **AND WHEREAS**, the ERC in its 223rd meeting held on 14th - 15th October, 2016 considered appeal order and decided that the previous decision of ERC is remain unchanged and the matter was forwarded to NCTE HQs. vide letter dated 15.10.2016 as a miscellaneous application for further directions.

5. **AND WHEREAS**, the NCTE HQs. vide letter No. 92-08/2016/Corres. ERC/Appeal/52545 dated 13.04.2017 referred the case to ERC to re-visit as per the decision of the Appellate Authority as contained in the Appeal Order pertaining to the institution. The ERC in its 238th meeting (Part-3) held on 18th - 20th April, 2017 considered the NCTE Hqrs. letter dated 13.04.2017 and decided that VT be constituted.

6. **AND WHEREAS**, the institution vide letter dated 24.05.2017 requested to give two months more time for inspection. The ERC in its 242nd meeting held on 15th - 16th July, 2017 consider the matter and as decided. Show Cause Notice u/s 14(3)(b) was issued on 02.08.2017 to the institution on the following grounds:

- (i) VT was decided in 238th ERC Meeting.
- (ii) The institution vide letter dated 24.05.2017 has requested to give two months more time for inspection due to ill health of Joint Secretary of Trustee Board of the management.
- (iii) As per NCTE Regulation 2014, inspection of the institution shall not be conducted as per the consent of the institution.
The Committee has not accepted the request of the institution.

7. AND WHEREAS, the institution had failed to submit reply in response to SCN dated 02.08.2017 within the stipulated time. The ERC in its 252nd meeting (Part-4) held on 28th February to 3rd March, 2018 after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act., the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqs from time to time and no reply received in response to SCN issued before VT, the Committee discussed the matter in detail and observed as under:

- a. Show Cause Notice u/s 14(3)(b) was issued on 02.08.2017 on the following grounds:
 - (i) VT was decided in 238th ERC Meeting.
 - (ii) The institution vide letter dated 24.05.2017 has requested to give two months more time for inspection due to ill health of Joint Secretary of Trustee Board of the management.
 - (iii) As per NCTE Regulation 2014, inspection of the institution shall not be conducted as per the consent of the institution.
 - (iv) The Committee has not accepted the request of the institution.
- b. Reply from the institution has not been received within the stipulated period.

In view the above, the Committee decided as under:

The Committee is of the opinion that application bearing Code No. ERCAPP3099 of the institution regarding recognition of applied B.Ed. Programme is refused under section 14(3)(b) of NCTE Act 1993.

8. NOW, THEREFORE, as per the decision of ERC, the application submitted by the applicant for grant of permission for **B.Ed.** course to the institution viz. **Sidhidata Sriniketan Siksha Mandir B.Ed. College, Plot No.- 753, Vill.- Siur, P.O.- Mohubona, Tehsil/Taluka- Sadaipur, Town/City- Suri, Dist.- Birbhum, West Bengal- 731102 (Code No. ERCAPP3099)** is hereby **Refused** in terms of section 14(3)(b) of NCTE Act 1993.

9. Further, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
