ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Samudragarh Social Welfare Council, Plot No.150, 151, 197, Vill.- Samudragarh, PO- Samudragarh, Tehsil/Taluka -- Kalna, Town/City- Kalna, Dist- Bardhaman, West Bengal- 713519 has applied for grant of recognition to Samudragarh Vivekananda Academy, Plot No- 150, 151, 197, Vill.- Samudragarh, PO- Samudragarh, Tehsil/Taluka – Kalna, Town/City- Kalna, Dist- Bardhaman, West Bengal- 713519 (Code No. ERCAPP3973) for D.El.Ed. Course online on 29.06.2015 for two year duration and hardcopy received by Eastern Regional Committee of NCTE on 07.07.2015.

2. AND WHEREAS, the ERC in its 202nd meeting held on 18th -23rd January, 2016 considered the matter and decided that VT be constituted. Accordingly, Inspection letter to the institution as well as visiting team experts were issued on 16.04.2016.

3. AND WHEREAS, the ERC in its 250th meeting (Part-2) held on 17th -18th February, 2018 after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act., the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqrs from time to time, discussed the matter in detail and observed as under:

- (i) Letters relating to inspection issued to the institution as well as VT experts on 16.04.2016.
- (ii) The VT experts viz. Dr. B. K. Praharaj & Dr. S. N. Panda vide their email dated 01.05.2016 & 02.05.2016 informed that the institution was hesitant for the visit on 23rd & 24th April, 2016 proposed by the VT for ongoing assembly election in West Bengal. Post elections the institution is not ready for inspection as it needs more time for building completion.
- (iii) As per NCTE Regulation 2014, inspection of the institution shall not be conducted as per the consent of the institution.

In view of the above, the Committee decided as under:

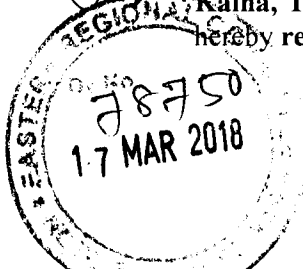
The Committee is of the opinion that application bearing Code No.ERCAPP3973 of the institution regarding recognition of applied D.El.Ed. Programme is refused under section 14(3)(b) of NCTE Act 1993.

4. NOW, THEREFORE, as per the decision of ERC, the application submitted by the applicant for grant of recognition for D.El.Ed. Course to the institution viz. Samudragarh Vivekananda Academy, Plot No- 150, 151, 197, Vill.- Samudragarh, PO- Samudragarh, Tehsil/Taluka – Kalna, Town/City- Kalna, Dist- Bardhaman, West Bengal- 713519 (Code No. ERCAPP3973) is hereby refused in terms of section 14(3)(b) of NCTE Act 1993.


