ORDER

WHEREAS, in terms of Section 15(1) of the NCTE Act, 1993, Nightingale Socio Development and Welfare Media, Plot No.- 520, Street/Road- Moregram-M, Vill- Moregram, PO- Madhaipur, Tehsil/Taluka- Malda, Town/City- Malda, Town, Dist- Malda, West Bengal- 732142 has applied for grant of recognition to Sidra B.Ed. College, Plot No.- 520, Street/Road- Moregram-M, Vill- Moregram, PO- Madhaipur, Tehsil/Taluka- Malda, Town/City- Malda Town, Dist- Malda, West Bengal- 732142 (Code No. ERCAPP4277) for D.El.Ed. programme online on 30.06.2015 for two year duration and hard copy received by Eastern Regional Committee of NCTE on 14.07.2015.

2. AND WHEREAS, the ERC in its 203rd meeting held on 4th – 6th February, 2016 considered the matter and decided that VT be constituted. Accordingly, VT letter was issued on 13.02.2016.

3. AND WHEREAS, the institution had submitted its representation dated 12.02.2016 received in ERC, NCTE on 24.02.2016. The ERC in its 214th meeting held on 13th - 15th May, 2016 considered the matter and as decided, Show Cause Notice u/s 15(3)(b) was issued on 26.12.2016 to the institution on the following grounds:

- (i) Inspection letter to the institution was issued on 13.02.2016.
- (ii) The institution vide letter dated 12.02.2016 (on the basis of website) has requested to extend time limit to carry out inspection of the institution as the present society is intending to apply for additional course in the next coming session in order to avail the all ultra modern facilities, which is not tenable and considerable under the provisions laid down by NCTE Regulation 2014.

4. AND WHEREAS, the institution had submitted reply dated 02.06.2016 & 12.08.2016 received in ERC, NCTE on 01.08.2016 & 22.08.2016. The ERC in its 225th meeting was held on 16th – 18th November, 2016 considered the matter and as decided, Show Cause Notice u/s 15(3)(b) was issued on 21.07.2016 to the institution on the following grounds:

- (i) Inspection letter was issued on 13.02.2016.
- (ii) VT not conducted so far.
- (iii) The VT experts namely Dr. A.K. Dubey and Shri R.K. Rout has submitted representation dated 24.10.2016 stating that “The said college avoided the inspection expressing their unpreparedness”.

5. AND WHEREAS, the institution had failed to submit reply within the stipulated time. The ERC in its 244th meeting held on 08th – 09th October, 2017 after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act, the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqrs. from time to time, discussed the matter in detail and observed as under:

(a) Show Cause Notice was issued on 26.12.2016 on the following grounds:

- (i) Inspection letter was issued on 13.02.2016.
- (ii) VT not conducted so far.

- (iii) The VT experts namely Dr. A.K. Dubey and Shri R.K. Rout has submitted representation dated 24.10.2016 stating that 'The said college avoided the inspection expressing their unpreparedness'.


(b) No reply received from institution till date.

In view the above, the Committee decided as under:

The Committee is of the opinion that application bearing Code No. ERCAPP4277 of the institution regarding permission of applied D.El.Ed. Programme is refused under section 15(3)(b) of NCTE Act, 1993.

6. NOW, THEREFORE, as per the decision of ERC, the application submitted by the applicant for grant of recognition for **D.El.Ed.** course to the institution viz. **Sidra B.Ed. College, Plot No.- 520, Street/Road- Moregram-M, Vill- Moregram, PO- Madhaipur, Tehsil/Taluka- Malda, Town/City- Malda Town, Dist- Malda, West Bengal- 732142 (Code No. ERCAPP4277)** is hereby **Refused** in terms of section 15(3)(b) of NCTE Act 1993.

7. Further, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
