**ORDER**

**WHEREAS**, in terms of Section 14(1) of the NCTE Act, 1993, Birsha Munda Seva Sameti, Plot No.- LR903/RS22, Street/Road- Main Road, Vill- Mukti Para, PO- Falakata, Tehsil/Taluka- Jaychand Pur, Town/City- Falakata, Dist- Jalpaiguri, West Bengal- 735211 has applied for grant of recognition for **B.Ed. Course to Falakata B.Ed. College, Plot No- 220, Street No- 05, Vill- Mukti Para, Jaychandpur, PO- Bhutanir Ghat, Tehsil/Taluka- Jaychandpur, Town/City- Falakata, Dist- Jalpaiguri, West Bengal- 735211 (Code No. APE00545)** was received by Eastern Regional Committee of NCTE on **29.11.2005**.

2. **AND WHEREAS**, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and videography, and the certificates received from the affiliating body, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

3. **AND WHEREAS**, as per the decision of 206<sup>th</sup> ERC Meeting held on 26<sup>th</sup> -27<sup>th</sup> February, 2016, **formal recognition order under clause 7(16)** was issued vide No. **ERC/7-73.6(b).13/2007/6238 dated 12.02.2007** for conducting **B.Ed. course** with an annual intake of **100 students** to the institution, followed by revised order no. 32370 dated 29.05.2015 as per NCTE Regulation, 2014.

4. **AND WHEREAS**, the recognition granted to B.Ed. course was withdrawn U/s 17(1) of the NCTE Act, 1993 from the academic session 2017-2018 vide order dated 02.05.2017.

5. **AND WHEREAS**, the institution filed W.P. No. 14231(w) of 2017 (Falakata B.Ed. College -Vs- NCTE & Ors.) in the Hon'ble High Court of Calcutta. The Hon'ble High Court of Calcutta vide its interim Order dated 17.05.2017 has directed as follows:

"Accordingly, awaiting appropriate instructions from the NCTE there shall be interim Order in terms of prayer marked (g), (h) and (i) of the Writ Petition until further orders."

- (g) Issue an order of injunction restraining the respondents, their men, agents and/or assigns to give any effect or further effect to the impugned decision arrived at against Agenda Nos. 237 and 239 pertaining to the petitioner college;
- (h) Issue an interim order staying the operation of any decision taken arrived at against Agenda Nos. 237 and 239 pertaining to the petitioner college;
- (i) Issue an interim order permitting the petitioner college to admit students in the B.Ed. and D.El.Ed. course subject to any condition imposed by this Honourable Court;
