**ORDER**

**WHEREAS**, in terms of Section 14(1) of the NCTE Act, 1993, Burdwan Welfare Trust, Vill. - Bhita, Street/Road - Bhita, Taluka/Mandal - Burdwan, Town/City - Burdwan, Dist - Bardhaman, West Bengal – 713102 has applied for grant of recognition to **Burdwan Teachers Training Institute, Vill - Bhita, Street/Road - Bhita, Taluka/Mandal - Burdwan, Town/City - Bhita, Dist - Bardhaman, West Bengal - 713102 (Application No. Not Generated) (ID No.-11137)** for additional intake of **B.Ed.** Course online on **20.06.2016** for two year duration and hardcopy received by Eastern Regional Committee of NCTE on **13.07.2016**.

2. **AND WHEREAS**, the ERC in its 223<sup>rd</sup> meeting held on 14<sup>th</sup> -15<sup>th</sup> October, 2016 considered the matter and decided to issue Show Cause Notice to the institution on the following grounds:

- Processing fee not submitted. No documentary proof submitted regarding submission of processing fee.
- As per the print out copy of the online application it is observed that Application Number is not available.
- The application is not appeared on the dashboard of the online NCTE portal due to which online process cannot be carried out.

3. **AND WHEREAS**, the institution submitted reply received vide letter dated 03.11.2016 (on the basis of proceedings uploaded on ERC website). The ERC in its 236<sup>th</sup> meeting held on 25<sup>th</sup> -28<sup>th</sup> March, 2017 after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act., the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqrs from time to time, discussed the matter in detail and observed as under:

a. Show Cause Notice decided in 223<sup>rd</sup> meeting on the following grounds:

- Processing fee not submitted. No documentary proof submitted regarding submission of processing fee.
- As per the print out copy of the online application it is observed that Application Number is not available.
- The application is not appeared on the dashboard of the online NCTE portal due to which online process cannot be carried out.

b. In response, the institution vide letter received dated 03.11.2016 has stated that due to Internet link failure they could not make online payment and requested to permit submission of D.D. mode payment. The Committee has not accepted the request of the institution.

**In view the above, the committee decided as under:**

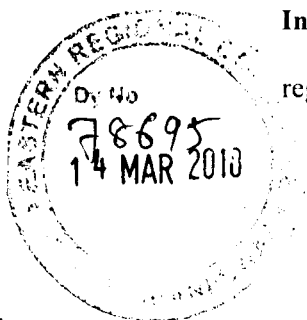
