## Order

In terms of Section 15(1) of the NCTE Act, 1993 Dev Sangha Institute of Professional Studies and Educational Research, Deoghar, Jharkhand-814114 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting E.T.E Course of two year duration from the academic session 2005-2006 with an annual intake of 50 (Fifty) students.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team, the Committee has noted the following:
  - i. The institution has acquired the land for setting up the teacher education institution.
  - ii. The institution has constructed the building for conducting the course on the above mentioned land.
  - iii. The institution is in process to construct additional structure in the present building.
  - iv. The institution has selected Principal and 05 (Five) teachers for the said course and the list of faculty members have not been approved by the concerned Directorate.
- 3. Now, therefore, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to **Dev Sangha Institute of Professional Studies and Educational Research, Deoghar, Jharkhand-814114** for ETE Course of two year duration from the academic session 2005-2006 with an annual intake of 50 (Fifty) students subject to fulfillment of the following:
  - a. The institution will ensure that Principal and at least 05 (five) faculty members duly approved by the affiliating body are in position for an intake of 50 students before the commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee
  - b. The Principal who is over-aged needs to be replaced by a person having required qualification and adequate experience as required under NCTE norms and the institution shall intimate the action taken in this regard to ERC, NCTE before commencement of the academic session.
  - The institution shall pay salary to the teaching staff as prescribed by State Govt./ UGC
  - d. The Institution will ensure that additional structure in the existing building be completed and report to this effect to be submitted to ERC.
  - e. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations

- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
