ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Mother Teresa Memorial Trust, Plot No.- 963, Street No.- Mithipur Road, Vill - Pukurkona, P.O.- Mithipur, Tehsil/Taluka- Raghunathganj, Town/City - Raghunathganj, Dist - Murshidabad, West Bengal - 742213 has applied for grant of recognition to **Mother Teresa Academy, Plot No.1216, 1213, Street No.- Mirzapur, Vill.-Sadikpur, P.O.-Gankar, Tehsil/Taluka- Raghunathganj, Town/City- Raghunathganj, Dist. - Murshidabad, West Bengal - 742227 (Code No. ERCAPP3940)** for B.Ed. Course online on 29.06.2015 for two year duration and hardcopy received by Eastern Regional Committee of NCTE on 10.07.2015.

2. AND WHEREAS, the ERC in its 240th meeting held on 19-20 May, 2017 considered the matter and decided that VT be constituted. Accordingly, VT constituted online for conduct of inspection during the schedule from 11.06.2017 to 01.07.2017.

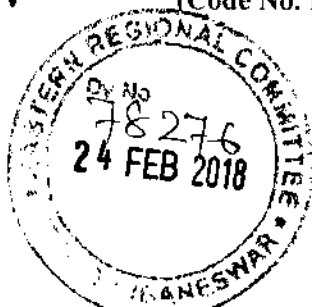
3. AND WHEREAS, the ERC in its 249th meeting (Part-2) held on 06-07 February, 2018 after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act., the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqrs from time to time, discussed the matter in detail and observed as under:

- (i) VT constituted online for conduct of inspection during the schedule from 11.06.2017 to 01.07.2017.
- (ii) As reported by the VT experts viz. Dr. Rajesh Prasad Shukla and Prof. Rajni Joshi vide their emails dated 30.06.2017 that the institution refused for conducting inspection on 28.06.2017 as fixed by them in consultation with the institution.
- (iii) As per NCTE Regulation 2014, inspection of the institution shall not be conducted as per the consent of the institution.

In view of the above, the Committee decided as under:

The Committee is of the opinion that application bearing Code No. ERCAPP3940 of the institution regarding recognition of applied B.Ed. Programme is refused under section 14(3)(b) of NCTE Act 1993

4. NOW, THEREFORE, as per the decision of ERC, the application submitted by the applicant for grant of recognition for B.Ed. Course to the institution viz. **Mother Teresa Academy, Plot No.1216, 1213, Street No.- Mirzapur, Vill.-Sadikpur, P.O.-Gankar, Tehsil/Taluka- Raghunathganj, Town/City- Raghunathganj, Dist. - Murshidabad, West Bengal - 742227 (Code No. ERCAPP3940)** is hereby refused in terms of section 14(3)(b) of NCTE Act 1993.
