Order

In terms of Section 14(1) of the NCTE Act, 1993 District Institute of Education & Training, Vill. Vidhyanagar, P.O. Paiturbazar, Kailashahar, North Tripura, Pin-799 279 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting U.G.T. Course of One year duration from the academic session 2004-2005 with an annual intake of 200 (Two hundred) students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- i) The institution has acquired the land for setting up the teacher education institution.
- ii) The institution proposes to function from its own building for conducting the course on the above mentioned land.
- iii) The institution building is under construction.
- iv) The affiliating body i.e. SCERT, Agartala, Tripura has submitted a list of teachers to be selected as Principal/ HOD and teachers out of that list for the said course.


3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **District Institute of Education & Training, Vill. Vidhyanagar, P.O. Paiturbazar, Kailashahar, North Tripura, Pin-799 279** for U.G.T. Course of One year duration from the academic session 2004-2005 with an annual intake of 50 (fifty) students subject to fulfillment of the following:

- a. That the institution will ensure that **Principal** and at least **05 (five)** faculty members duly approved by the affiliating body are in position for an intake of **50 (fifty)** students before commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee within one month of commencement of the course.
- b. The institution will appoint requisite qualified teaching staff as indicated above, maintain infrastructural and instructional facilities as per NCTE norms, and list of teaching staff countersigned by the affiliating authority shall be submitted to the Eastern Regional Committee within one month of commencement of academic session.
- c. The duration of one year will be changed to two years from the session 2005-2006 as per NCTE norms.
- d. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc.
5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating body to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
