As per provisions u/s 17(4) of the NCTE Act, 1993, if an institution offers any course or training in Teacher Education without obtaining recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government. 6. The Committee suggested to prepare Data Bank for the teachers. 7. The institution needs to install Fire Safety equipment and submit the Fire Safety Certificate if not submitted earlier. 8. The cutoff date for granting/refusal of recognition for the session 2017-18 was 3rd March, 2017 and now Hon'ble Supreme Court of India extended the time for getting recognition/refusal up to 2nd May, 2017, hence, the institution may submit the compliance on the basis of proceedings uploaded in the ERC NCTE website.
