The VT report strongly recommended for recognition, despite that land area as per land document is not as much as required.</li> <li>2. The Commissioner to the Government of Nagaland has stated in his letter No HTE/MISC-3/2012 dt 17 Jul 12 that about 65 % of govt school teachers and 80 % of private school teachers are untrained, and serious efforts to train them in next few years is required under RTE Act. The govt is encouraging even private players to open B.Ed colleges in the state. Moreover, Nagaland being tribal and hilly area, some relaxation is required to be extended to the state The State Government will ensure that the deficiency is rectified at the shortest possible time.</li> </ol> <p>In view of the above the committee decided as under:</p> <ol style="list-style-type: none"> <li>1. The State Government of Nagaland is requested to approach the NCTE Hqr for relaxation under clause 12 of regulation.</li> <li>2. Letter of Intent under clause 7(9) of NCTE Regulation 2009 may be issued to the institution subject to the condition that the relaxation under clause 12 of regulation is obtained prior to the formal recognition to the institution.</li> </ol>
