ORDER

WHEREAS, **Satyanam Satyaguru B.Ed. College, Vill - Ayachigram, Bairiya, Muzaffarpur, Street/ Road - Ayachigram, Main Road, Taluka/ Mandal - Kanti, Town/ City - Ayachigram, Bairiya, Muzaffarpur, Dist. - Muzaffarpur, Bihar - 842003** had applied through online dated **23.06.2016** for grant of recognition for **D.El.Ed. & B.Ed. Courses** under viz. **Maya Sewak Educational Trust, Vill - Bramhpura, Street/ Road - Thana Chowk, Taluka/ Mandal - Muzaffarpur, Town/ City - Muzaffarpur, Dist. - Muzaffarpur, Bihar - 842003 (Code No.ERCAPP201646192)** of **two year** duration Under Section 14 of the NCTE Act 1993 and hard copy of the application was received on **25.07.2016** by the ERC office.

2. AND WHEREAS, the Eastern Regional Committee in its 226th meeting held on 29th – 30th November, 2016 after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act, the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqrs from time to time, and SCN issued before VT, the Committee discussed the matter in detail and observed as under:

- a. SCN was issued on 20.09.2016 on the following grounds:
- The date of application through online is 23.06.2016 and date of receipt of hard copy of online print out application is 25.07.2016 i.e. after the 15th July 2015.
 - The institution submitted its representation dated 07.10.2016 with a request to consider the application for granting recognition to the applied course. The committee considered the representation of the institution and observed that the institution is deficient on SCN ground which is not acceptable.

In view the above, the committee decided as under:

The committee is of the opinion that application bearing Application No.ERCAPP201646192 of the institution regarding recognition of B.Ed. & D.El.Ed. Programme is refused under section 14(3)(b) of NCTE Act 1993.

3. NOW, THEREFORE, as per the decision of ERC, the application submitted by the applicant for grant of recognition for **D.El.Ed. & B.Ed. Course** to viz. **Satyanam Satyaguru B.Ed. College, Vill - Ayachigram, Bairiya, Muzaffarpur, Street/ Road - Ayachigram, Main Road, Taluka/ Mandal - Kanti, Town/ City - Ayachigram, Bairiya, Muzaffarpur, Dist. - Muzaffarpur, Bihar - 842003 (ID. No.8140)** is hereby **refused** under section 14(3)(b) of NCTE Act 1993.


