SHOW CAUSE NOTICE

WHEREAS, Phansidewa Kabi Guru Rabindra Nath Educational Society, Village- Subhaspally, Street/Road - 2nd by Lane J.C. Bose Road, Taluka/Mandal - Subhaspally, Town/City - Siliguri, Dist. - Darjiling, West Bengal - 734001 had applied through online dated 29.06.2016 for grant of recognition / permissionforconduct of D.El.Ed. Course of two year duration under theinstitution viz. Vidyasagar College of Education, Village-Rupandighi, PO & PS - Phansidewa, Street/Road - Phansidewa Road, Taluka/Mandal - Phansidewa Block, Town/City - Rupandighi, Dist.- Darjiling, West Bengal - 734434 (ID No. 9400) Under Section 14/15 of the NCTE Act 1993 and hard copy of the application was received on 11.07.2016 by the ERC office.

- 2. AND WHEREAS, the ERC in its 223rd meeting held on 14th- 15th October 2016, after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act., the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqrs from time to time, the Eastern Regional Committee observed as under:
 - (i) Processing fee not submitted. No documentary proof submitted regarding submission of processing fee.
- (ii) As per the print out copy of the online application it is observed that Application number is not available.
- (iii) The application is not appeared on the dashboard of the online NCTE portal due to which online process cannot be carried out.

In view the above, the committee decided as under:

Show Cause Notice be issued to the institution as to why the recognition to the institution be not refused on the above points. The Committee therefore, provides last opportunity under section 15(3)(b) of the NCTE Act 1993 to the institution to submit its reply within 21 days from the issue of this letter before the Committee takes final decision.

- 3. And whereas the Committee is of the opinion that the institution prima facie, does not fulfill the requirements, the norms and standards laid down by the NCTE in accordance with the provisions of the NCTE Act, 1993, as detailed above.
- 4. Now therefore, as per the Section 15(3)(b) of NCTE Act, 1993, before the Regional Committee passes the final order on your application, you are hereby given an opportunity for making such written representation within 21 days of issue of this notice along with the supporting documents.
- In the event of this office not receiving representation within 21 days from the date of issue of this notice, it will be presumed that you do not wish to make any representation and the Regional Committee shall take decision as it deems fit and proper. However, if the institution has already submitted the reply in response to uploaded minutes of 223rd Meeting of ERC in its Website, the same shall be treated as the reply to the decision of ERC.
